



## CITY OF KATY PROPERTY TAX PAYMENTS

Dear Citizen:

Katy City Council recently voted to consolidate property tax collections by joint-venturing with the Harris and Fort Bend County Tax Assessor-Collectors' offices.

Starting this Fall, City of Katy property taxes for Harris County residents will be included on the Harris County Tax Assessor-Collector's tax bills. Taxes for residents of Fort Bend and Waller counties will be included on the Fort Bend County Tax Assessor-Collector's tax bills. Those residents with properties in multiple counties, may receive a bill from each county.

Taxpayers' benefits:

- Fewer tax statements
- Fewer checks written
- Enhanced payment options
- Reduced trips to multiple tax offices
- More convenient locations for personal assistance
- Eliminates duplicate functions, saving money and time.

The former City of Katy Tax Office will no longer accept payments, as of September 1, 2015. The staff will be available to answer tax questions for citizens until January 31, 2016. The Harris County Tax Assessor-Collector offers sixteen (16) branch locations. The Fort Bend Tax Assessor-Collector offers five (5) branch locations. Both counties also have online services available for credit card and e-check payments.
