Tom Burnett, Southland Conference, reported on another successful basketball event and commented on the increasing attendance. He spoke of the additional hotels located within the city limits and complimented the City on their hospitality. He gave a brief presentation on the 2015 Basketball Tournament held March 11-15, 2015, at the Merrell Center. All voted Aye, and the motion carried.

City Administrator Hebert explained the proposed system will allow the Permit/Inspections Department to be more efficient, especially since the volume of permits has increased and will continue to do so. Motion was made by Councilmember Pierson, seconded by Councilmember Brawner, approving as printed and read (caption) an Ordinance (No. 2695) Declaring the Intention of the City of Katy to Remove Certain Territory from Waller-Harris Emergency Services District Number 200 and for the City of Katy to be the Sole Provider of Emergency Services to the Territory. City Attorney Pertile explained a notice will be send to Waller-Harris Emergency Services District Number 200 notifying them of the recently annexed property into the city limits and that no services will be required for these areas from the District. All voted Aye, and the motion carried.

Councilmembers' Report

Councilmember Mendez thanked Permits/Inspections Department for their service. commented he was not aware of the Permits/Inspections enforcement procedures until he became a Code Enforcer himself. He reported the Mayor and he attended the Grand Opening of the Katy Independent School District Robert R. Shaw Center for STEAM earlier in the day and that it was wonderful to see the kids with the robotics, science experiments and to watch the light in their eyes for their accomplishments. Councilmember Dowdle congratulated the Permit/Inspections Department on their recognition. He understands there are codes that must be abided by and he appreciates all they do. He thanked Southland Conference Representative Burnett and Katy Rice Harvest Festival Representatives for the partnership with the City. Councilmember Pierson thanked Permit/Inspections for their service and understands they receive a negative rap sometimes, but he is glad he lives in a city that has an Inspection Department that sees that quality buildings are built. He believes in the current standards of the City. He believes the City is blessed with the promotions of the Arts by local museums, Katy Economic Development Association and recent Katy Jazz Festival. He thanked Bob Bryant for his promotion of the City during the festival. He stated he is proud to live and serve in the City of Katy. Councilmember Lawton spoke of his past experience on the City Planning & Zoning Commission and believes the Permits/Inspections Department have a tough job enforcing building regulation. He thanked them for their advice and assistance to the citizens. He hopes for a blue sky during the upcoming Rice Harvest Festival and welcomed Southland Conference back for 2016. Councilmember Brawner commented that Permits/Inspection Staff's recognition is well deserved and was pleased to see all the green stickers in Cane Island Development. He thanked them for staying ahead with inspections. He thanked Public Works Director Lutringer and her staff for dealing with all of the heat from builders. He expressed appreciation to the Boy Scouts for their attendance.

The Mayor thanked Southland Conference Representative Tom Burnett and Katy Rice Harvest Festival Representatives Bob and Ann Hodge for their successful events conducted within the city limits. He thanked Public Works Director Elaine Lutringer and her staff for the excellent job in enforcement of City regulations.
