The Mayor presented a Proclamation Recognizing October 2016 as "Domestic Violence Awareness Month" to Katy Christian Ministries Representatives.

Public Hearing for Proposed Ordinance Amending Zoning Ordinance No. 621; Changing the Zoning for "The Reserve At Katy" Planned Development District from Planned Development District to a Single Family Residential Development of 100 Acres or More Planned Development District; Amending Lot Size and Signage Regulations: Allowing for Future Subdivision of Tracts of Land within "The Reserve At Katy" 100 Acre Planned Development District

The Mayor opened a Public Hearing at 6:38 p.m. for a Proposed Ordinance Amending Zoning Ordinance No. 621; Changing the Zoning for "The Reserve At Katy" Planned Development District from Planned Development District to a Single Family Residential Development of 100 Acres or More Planned Development District; Amending Lot Size and Signage Regulations: Allowing for Future Subdivision of Tracts of Land within "The Reserve At Katy" 100 Acre Planned Development District. Kerry, Kerry Gilbert & Associates, Representative for The Reserve At Katy, explained the proposed is an amendment is for three changes. 1) Proposed change for the lot sizes west of Spring Green Drive, which still exceed the minimum lot size required by the City and will be 16 lots less that previously permitted. 2) Proposed change to allow for a fifty foot right-of-way for the roadway out of Firethorne and the cul-de-sac that parallels the road. He commented both City Staff and the City Planning and Zoning Commission agreed to allow for the fifty foot right-of-way. 3) Proposed change making a minor correction to the sign portion of the agreement, allowing the same number of signs; however, allowing for a one tenant sign to become a two tenant sign. Gilbert commented he believes these changes to be minor and CPZ passed unanimously and there were representatives present from Toll Brothers, it there were any questions. The Mayor closed the Public Hearing at 6:41 p.m.
